DECLARATION, UNDERTAKING AND AGREEMENT BY OWNER OR AGENT

<p>1. I HEREBY DECLARE that the dog or dogs entered by me immediately prior to the show with any dog which was REGISTERED in my name with the Irish Kennel Club previously inoculated with distemper virus within 30 days. Ltd.</p> <p>2. I HEREBY DECLARE that the dog or dogs entered by me are not vicious, and are bonafide my property, and I enter them subject to the Rules of the Irish Kennel Club Ltd, and the Regulations of the Show which appear in the schedule, and which I have read.</p> <p>3. I HEREBY DECLARE not to bring within the precincts of the show any dog which (1) has distemper or other communicable disease; (2) has had distemper or other communicable disease unless it has been fully recovered for more than 30 days immediately prior to the show or (3) has been in contact with or in any kennels or establishment containing distemper or communicable disease during the 30 days immediately prior to the show or (4) has been inoculated with distemper virus or displayed any reaction there from during the 30 days immediately prior to the show or (5) has been in contact during the 30 days immediately prior to the show with any dog which was previously inoculated with distemper virus within 30 days.</p>	<p>4. IN CONSIDERATION) of my entry being accepted I hereby agree (1) to indemnify the Irish Kennel Club Ltd. and/or its Trustees and/or its Officials in respect of any damage or loss from whatever source arising, caused by or to any dog exhibited by me while in the precincts of the show. (2) That any decision given concerning be by the Irish Kennel Club Ltd., or by any committee thereof in connection with any matter whatsoever arising through or at this show, shall be communicated by the secretary of the Irish Kennel Club Ltd, it may concern, and that such decision, together with a report of the proceedings in the matter may also be published together with my name, address and description.</p> <p>5. I HEREBY UNDERTAKE to abide be the Rules and Kennel Regulations of the Irish Club Ltd., and of the show.</p> <p>6. I UNDERTAKE to indemnify the promoters against the claims arising out of my participation as a competitor in the show.</p>

Class Definitions
(The word "Dog" includes both Sexes)

A Puppy Class is confined to dogs over six and under twelve calendar months of age on the day of the Show, computed from and inclusive of the date of its birth.

A Junior Class is for dogs between 9 and 18 calendar months of age on the day of the Show, computed from and inclusive of the date of its birth.

An Open Class is for dogs over 15 months of age on the day of the Show, computed from and inclusive of the date of its birth.

A Veteran Class is for dogs over 8 years of age on the day of the Show, computed from and inclusive of the date of its birth.

Please Note: A veteran dog who is a champion may enter in either veteran or champion class but not both.

All dogs exhibited must be registered with the Irish Kennel Club and if Ownership of the dog has changed since registration the **TRANSFER** must be registered before the Show.

Entry form must be made by the owner or his/her agent and the particulars furnished below must be exactly the same as registered.

Entries will **NOT** be accepted without fees which should be paid by crossed cheque, postal or money order, and sent to **Hon. Secretary** address on front cover.
